

2022 StarMed Hornets Game Giveaway

Official Rules

Eligibility: The 2022 StarMed Hornets Game Giveaway (the “Promotion”) is open only to legal residents of the 50 United States and the District of Columbia, who are 13 years of age or older and reside in the U.S. at the time of entry. Void elsewhere and where prohibited by law.
